Failure to comply will result in immediate termination of participation in the activities and parental/notification. Any and all liability for the vehicle and its operation at any and all times will be the sole and absolute responsibility of the above named cadet and their parent(s)/guardian. I(we) hereby certify the above named cadet has a valid unrestricted drivers license, the vehicle has a valid registration, the vehicle bears a current inspection sticker, the vehicle and driver are insured to at least Pennsylvania minimum standards, and I (we) and the above named cadet are fully and solely liable for any damages in excess of vehicle insurance limits of coverage. While participating in activities, **a copy of valid drivers license, valid vehicle registration, and proof of adequate current insurance will be carried in the vehicle or by the above named cadet at all times available for inspection to the satisfaction of the property owner(s). Failure to do so will prohibit the cadet from driving to or at the activities.**
6. state and certify I (we) understand I (we) are entirely responsible for all expenses incurred in rendering of any medical treatment in the event of accident/injury to the above named cadet, and
7. verify the cadet named above will show proper respect for the property of others and will minimally impact the property owner(s) land. All equipment and materials brought to the activities must be removed at the termination of the activities, particularly trash. Failure to adequately remove same may result in significant liability and costs.
